## **EXTRACTS FROM THE "PHILIPPINE IMMIGRATION ACT OF 1940"**

Sec. 29 (a). The following classes of aliens shall be excluded from the entry into the Philippines:

- (1) Idiots or insane persons and persons who had been insane;
- (2) Persons afflicted with a loathsome or dangerous contagious disease, or epilepsy
- (3) Persons likely to become a public charge:

## **EXCERPTS FROM ADMINISTRATIVE ORDER No. 2**

(Bureau of Immigration)

### **Classification of defective and diseased Aliens**

24. For administrative purposes all certificates rendered by medical officers for the information of proper officers, certifying that an alien is afflicted with any one or more than one of the excluded classes of physical or mental defects, or diseases enumerated in paragraph 4 of these regulations, shall be separated into three groups which shall be designated as follows:

CLASS A. - Certifies that an alien is afflicted with any condition properly classified as a mental disease, or a loathsome or dangerous contagious disease.

CLASS B. - Certifies that an alien is afflicted with any condition properly classified as a physical or mental defect or disease (other than Class A disease or defect) which may affect ability to earn a living. These certifications are subject to administrative consideration with respect to the final rejection or admission of an alien so certified.

CLASS C. - Certifies that an alien is afflicted with any condition properly classified as a physical defect or disease (other than Class A or B disease or defect) which is minor or transient in nature and not likely to affect the ability to earn a living.

## **VISA APPLICANTS REQUIRING CONSULAR MEDICAL EXAMINATION**

A. Non-immigrants.

1. Student
2. Applicants for prearranged employment visas

B. All immigrants.

C. Applicants obviously afflicted with a Class A condition.

Note: Blood exam not necessary for applicants less than 14 years old, unless obviously indicated.
